#### STRUCTURE GOVERNANCE AND MANAGEMENT

# **Governing Document**

The charity is an unincorporated association governed by its constitution last revised in November 2013. It was granted charitable status and became a Scottish Charity on 28 March 2006.

### **Appointment of Trustees**

Trustees, who for serve for a period of one year, are elected by the members of the society at the Annual General Meeting, but may then be re-elected. The minimum number of trustees is four.

Any newly appointed trustees are advised of the constitution, objectives and activities of the Society, and their responsibilities under the Charities & Trustee Investment (Scotland) Act 2005. A comprehensive induction Pack is provided to all new trustees.

#### **Risk Assessment**

The trustees regularly review the risks to which the Society. The trustees accept that the Society is dependent upon receiving sufficient funding and donations to enable it to continue to work towards achieving its objectives. Fund raising opportunities are explored to ensure that this remains the case.

#### **OBJECTS & ACTIVITIES**

The Society's object is to promote Scotland – Japan relations, specifically:

- to promote learning and advance education in the subject of and with regard to Japan;
- to promote the study of Japan and its people in all their aspects, traditional and modern, and to make the results of such study more accessible to the general public;
- to promote the study of Scotland and its culture by Japanese people and to further educational exchanges between Scotland and Japan; and
- the advancement of public education in Japanese and Scottish culture and arts by means of, but not limited to, the provision of grants and awards and the establishment of scholarships.

#### **ACHIEVEMENTS & PERFORMANCE**

It has been another successful year at the society, with a full programme of events.

Highlights include fascinating lectures by Professor Ian Gow on Japan's involvement in the First World War, a lecture by Professor Ikuo Yamamoto of Nagasaki University on Robotics in Japan and a lecture on Scots and the making of Meiji Japan by Professor Masami Kita of Soka University.

We visited the exhibition of early photographs of Japan collected by Andrew Carnegie held in his birthplace museum in Dunfermline and financially supported the "Paper from Across the Sea" Printmakers exhibition which was unveiled in Edinburgh in November. We participated in and financially supported the Japanese Children's Day events in Orkney in May.

Our scholarship winner for 2017, Mark Livingstone, was selected in January. He thoroughly enjoyed his time in Japan in the summer and did exceptionally well in his language studies.

Pittencrieff Park Dunfermline provided a very picturesque setting for our AGM on 29th April 2017 and we will be looking for a similar venue in 2018.

During 2017 we were able to support a number of primary schools who had Japan related projects and will continue this initiative in 2018.

The last event for 2017 was the Bonenkai in Edinburgh and as with previous years all available places at the event were taken.

The society would not be able to function without the volunteer council members. Many thanks to everyone involved for their continued support in all society matters.

#### **FINANCIAL REVIEW**

#### Overview

Receipts & Payments on the unrestricted funds were £3,437 (2016: £2,981) and £7,230 (2016: £2,716 respectively, resulting in a deficit of £3,793 (2016: surplus of £265). The principal sources of income continue to be membership fees, donations and contributions towards the cost of events.

The restricted fund was created through grant funding from Aberdeen Standard Investments, part of Standard Life Aberdeen plc (formerly Aberdeen Asset Management plc), for which the trustees are very grateful, to fund Scholarships. The cost of the 2017 Scholarship was met from this fund leaving a balance of £15,124 to be carried forward to 2018.

# **Reserves Policy**

The trustees consider that around £10,000 is an appropriate level of reserves to hold in order to maintain its programme and to provide additional opportunities for Scottish students to study Japanese. Reserves at the period-end were £19,826 (2016: £23,619) which is higher than the target range.

#### **FUTURE PLANS**

Alex Donald from Aberdeen has been selected as the 2018 Aberdeen Standards Investment/Japan Society of Scotland to attend the International Christian University in Tokyo over the summer to study Japanese and we wish him all the best in his studies. We are also finalising an exciting programme of lectures and activities for the coming year, working together with the staff of the Japanese Consulate in Edinburgh.

#### THE ADVENTURES OF MARK LIVINGSTONE, OUR 2017 SCHOLARSHIP STUDENT

Firstly, I would like to say a massive thank you to both the Japan Society of Scotland and Aberdeen Asset Management for making the scholarship possible. I had the best time of my life, and words could not express how grateful I am for having had the opportunity to go on this scholarship and experience life in Japan for 2 months.

The scholarship, having sent me to study on one of ICU's Summer Courses in Japanese Programs, built in me the confidence and gave me the knowledge required to have short conversations in Japanese. This was enough to be able to have basic conversations with people I did not know, and gave me the knowledge to be helpful in establishments where language barriers presented themselves. For example, I was able to answer questions Japanese people would ask me on the train, about where the train is going, where I have come from, describe Scotland a little and to describe what I would like to do in the future! I was also able to be helpful as a result of my gained knowledge in Amsterdam, at Schiphol airport on my way home, when flight attendants at the gate asked a Japanese citizen if he was born in Tokyo. However, the man couldn't understand their English, and so I stepped in to ask the man: 「東京で生まれましたか。」 and he was able to understand me and replied 「はい、そうです。」. This really validated the trip for me, as I could use my Japanese in a professional context, and be able to be helpful to people.

I enjoyed getting to do cultural exchange with all the students there, asking them what life is like in their country, and being able to tell them about things in Scotland, ranging from the food to the culture, as well as a fair amount of the accent, leaving many people saying "Dinnae dae this tae me lad" as I set off back home.

As for the career side of things, the scholarship has also helped me. It has given me a contact that I can keep in touch with during the future, and who is friends with people who work at one of the companies I would like to work with in the future. Through this, I am able to have a grasp on what it will be like working in Japan in the future, and can continue to have a link in Japan to its world of creative industries.

The scholarship has changed my life for the better in many ways, not least of which being the motivation it has given me to strive in my chosen career's field, so that I may yet be able to go to Japan again in the future, and further on, live and work there.

To future students on the scholarship, I have a few recommendations:

Make friends that speak better Japanese than you do:

This helped me immensely. I made friends with Americans who spoke at JPLT N1 and N3 level, and being able to ask them any questions I had helped me learn a lot more than I would have struggling on my own to find what things mean. Furthermore, seeing them be able to speak and converse naturally with Japanese people and read almost as if it were English gave me a lot of motivation during my time there, and I found that motivation invaluable.

Get out and talk to people:

While the classes provide you with plenty of speaking experience, both with Japanese natives and your classmates, I cannot recommend enough getting out and talking to people. Whether this is a simple 何階 in an elevator to people getting in, or a conversation with someone you meet on the train, or even asking for things in a convenience store, everything will be useful for practicing some aspect of speaking or listening.

Finally, thank you again to the people who made this trip possible. Because of it, I am a better person, and will continue to study and work hard so that I can achieve my dream of living and working in Japan.





#### INDEPENDENT EXAMINER'S REPORT

### Independent Examiner's Report to the Trustees of Japan Society of Scotland

I report on the accounts of the charity for the year ended 31 December 2017, which are set out on pages 9 to 12.

### Respective responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ("the 2005 Act") and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations"). The trustees consider that the audit requirement of Regulation (10)(1)(d) of the 2006 Regulations does not apply.

It is my responsibility to examine the accounts under section (44)(1)(c) of the 2005 Act and to state whether particular matters have come to my attention.

### **Basis of Independent Examiner's Statement**

My examination is carried out in accordance with Regulation 11 of the 2006 Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

# NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31 DECEMBER 2017

# 1. Basis of Preparation

These accounts have been prepared on the receipts & payments basis in accordance with:

- (a) The Charities and Trustee Investment (Scotland) Act 2005
- (b) The Charities Accounts (Scotland) Regulations 2006 (as amended)

# 2. Change to the Basis of Preparation

No change has been made to the basis of preparation of the accounts or to the accounts for the previous period. However, the comparative figures cover the nine-month period to 31 December 2016, and are thus not directly comparable.

# 3. Fund Accounting

- (a) Unrestricted funds are those that can be expended at the discretion of the trustees in the furtherance of the objects of the charity.
- (b) Designated funds are unrestricted funds that the trustees have set aside for particular purposes. The designation is administrative only and does not restrict the trustees' ability to apply the funds.
- (c) Restricted funds are those that may only be used for specific purposes. Restrictions arise when specified by the donor, or when funds are raised for specific purposes.
- (d) The purposes of the funds are shown in Note 7.

# 4. Taxation

- (a) The charity is not liable to corporation tax or capital gains tax on its charitable activities.
- (b) The charity is not registered for VAT, thus all costs are shown inclusive of VAT charged.
